STUDENT'S RIGHT TO CANCEL

In calculating any tuition refund due the period of enrollment is from the first day in class to the last date of recorded attendance, the time and percentage or fraction of attendance will be determined by the time of attendance divided by the total hours in the program. In all cases of students who withdraw, or who are suspended or expelled, or fail to attend classes for 3 weeks prior to successful completion, or if the school closes prior to completing a course, the following minimum refund policy shall apply: The refund of tuition and other fees (excluding equipment fees) shall be equal to the total amount of tuition multiplied by the fraction or percentage of time remaining.
